To inform the design and implementation of the 4th country programme (CP), a mapping of existing evaluative evidence was conducted, grounded in a comprehensive analysis of country-level, regional and centralized evaluation reports on strategically important areas, including sexual and reproductive health (SRH), gender-based violence (GBV), and demographic resilience. The costed evaluation plan (CEPlan) has been developed based on the mapping document, which highlights data gaps related to the outputs of the new CP and informs the country office's strategy to address these gaps through diverse evaluation processes during the 4th programme cycle						
important to inform the design and implementation of the upcoming country programme	For <b>Output 1.1 of the CP</b> , the CPE will assess UNFPA's contribution to improving the accessibility and use of demographic data from the 2030 census round, usage of the National Transfer Accounts (NTAs) and the Results Based Budgeting (RBB) by national and local stakeholders, addressing the evidence gap on UNFPA's technical support to register-based population and housing censuses that leverage digital technologies for enumeration (internet-based self-enumeration) and census data processing (AI use for data processing), applying demographic data for socio-economic planning.						
	For <b>Output 2.1 of the CP</b> , the CPE will provide further evidence on the impact of men's low life expectancy on the quality of the lives of women and families, the influence of gender stereotypes and social norms on the life expectancy gap between men and women, and the effectiveness of communication strategies designed to target male health as the key determinant of families' and individuals' well-being.						

For **Output 3.1 of the CP**, the CPE will address evidence gaps related to the effectiveness of the national GBV response mechanism, including the performance of multi-sectoral response services, with focus on the most vulnerable groups, the functioning of referral pathways, as well as the availability and quality of GBV prevalence data and reporting barriers.

For **Output 3.2 of the CP**, the CPE will assess the effectiveness of the introduction and promotion of family-friendly policies and programmes at workplaces, the effects of the expansion of the family planning concept on advancing gender equality and supporting the reproductive choices of families and individuals, and the effectiveness of the intergenerational ("silver" and youth) bridging initiative.

Given the cross-cutting nature of humanitarian aspects across all outputs of the country programme and focusing on emergency preparedness interventions, the CPE of the 4th programme cycle (2026-2030 will assess the integration of emergency preparedness and response within the health and social protection systems in the areas of SRH, GBV, disaggregated data systems to inform humanitarian decision-making. It will also evaluate how UNFPA's humanitarian interventions complement developing programming, ensuring the continuity of essential services, particularly for women and adolescents and youth, while strengthening national resilience and emergency response capacities.
