	1. The evaluation of the United Nations Development Assistance Framework (UNDAF) for the period of 2018-2022 was conducted during 2021-2022 by a team of independent evaluation experts. The main purpose of the evaluation was to generate evidence on performance and adaptability of the UNDAF (2018-2022), based on selected criteria to contribute to greater learning of the UN Country Team (UNCT) in Nepal, as well as to support greater accountability and transparency of the UNDAF stakeholders.					
	2. The final evaluation of the 'AWAAZ – Inclusion for and by persons with disabilities' project that was implemented by UN Women, UNFPA, WHO and UNDP in 2022. The main purpose of the evaluation was to assess the results and approaches of the project interventions and their contribution to higher-level results (outcome level). The evaluation sought to identify and document the results achieved through the project interventions, challenges encountered as well as to document the lessons learned and best practices. The findings of the evaluation have provided specific recommendations for the future country programmes of the four UN partner agencies and stakeholders willing to contribute to the promotion of the rights of persons with disabilities.					
	3. The Country Programme and its Costed Evaluation Plan also take into account findings and recommendations of recent corporate evaluations, such as: (i) Evaluation of UNFPA support to the prevention, response to and elimination of gender based violence and harmful practices (2012-2017); (ii) Evaluation of UNFPA support to gender equality and women's empowerment (2012-2020); (iii) Developmental evaluation of results-based management at UNFPA (2019); (iv) Evaluation of the UNFPA capacity in humanitarian action (2012-2019); (v) Joint evaluation of the UNFPA-UNICEF Global Programme to Accelerate Action to End Child Marriage (2019); (vi) Mid-term evaluation of UNFPA's Supplies programme (2013-2020); and (vii) Formative evaluation of UNFPA's approach to South-South and triangular cooperation (2020).
