

COSTED EVALUATION PLAN -DRAFT

For the 7th Cycle Multi Country Programme for Pacific Island Countries and Territories 2023-2027 (MCPD7)

Abstract

This costed, multi-year evaluation plan describes and budgets for all evaluative activities that will be undertaken over the duration of the MCPD7 and constitutes a commitment for UNFPA Pacific Sub Regional Office. The plan constitutes the basis for planning, prioritizing, costing, mobilizing resources, and funding of all evaluative activities. The evaluation plan will support the implementation of the evaluation function at UNFPA and the Evaluation Office will report on its implementation to senior management and the Executive Board. It contains important information related to the MCPD7 and evaluative activities including: main areas of programme support, evidence utilized in the design of the costed plan, evaluative activities and their purpose, partners, time frames, and level of financial resources needed. The audience of this document is the PSRO M&E Unit, APRO, the PRC, UNFPA Executive Board, and stakeholders and partners in the Pacific.

Programme Cycle:	7 th Cycle – 2023 -2027
	As per the UNFPA Evaluation Policy 2019, this Multi Country Costed Evaluation Plan has been developed following an assessment of the existin evaluative evidence, knowledge base and consultative exercises outlined below:
	1. The UNFPA Pacific Sub-Regional office has completed an evaluation in every cycle. However, with the 2019 Global UNFPA evaluation policy, w are now only required to do an evaluation once in every 2 cycles, or 1 in every 10 years.
	2. Thus, since a full Multi-Country Programme Evaluation was completed in 2022, the penultimate year of the 6th Sub-Regional Programme, the evaluation plan for the MCPD7 2023-2027 has replaced the need for an end-of-programme evaluation with thematic evaluations.
	3. These thematic evaluations would conduct in-depth assessments of the key areas of investment, to see if we are making a systemic impact toward achieving the SDGs. We would need to explore the in-depth thematic issues to better inform our theories of change and fine tune our future programme to accelerate the achievement of results, given we have only 8 years left to the SDG target timeframe of 2030.
	4. The Evaluation of the 6 th Cycle Sub Regional Programme for Pacific Island countries and Territories 2018-2022 was conducted in 2021-2022 by a external evaluation team which also included a young emerging evaluator in accordance with the UNFPA Evaluation Policy 2019 and the UNFF Evaluation handbook 2019. The evaluation highlighted the importance of investing in new resources in its monitoring and evaluation infrastructurat PSRO level in Suva, Fiji, and further invest new resources in monitoring and evaluation at country office level.
Evidence utilized in the design of the costed plan	5. The evaluation of the United Nations Pacific Strategy (UNPS) 2018-2022 was also conducted during 2021-2022 by a team of independent evaluation experts. The UNPS evaluation emphasized that the UNCT should strengthen its overall M&E infrastructure. Given the enormity challenges in this area and the need for much stronger coordination, the whole enterprise of improving the M&E system in the Pacific region we benefit for a systematic review of the challenges and options undertaken jointly by the three RCOs with the blessing of the UNCT. This exercise could comprise an assessment of all key components of the M&E infrastructure, including coordination, data aggregation mechanisms, UN Inspirem, use of indicators, baselines, targets, etc.
	6. An evaluability assessment of the 6 th Cycle Sub Regional Programme for Pacific Island countries and Territories 2018-2022 was conducted November 2019 by an independent team of 2 consultants. The assessment recommended UNFPA should: continue supporting existing efforts of developing a full-fledged PM&E function by ensuring a more systematic and comprehensive approach; keep developing existing partnerships ar ensure a stronger support in PM&E matters, more transparency and participation at all levels; and ensure the implementation process adequately carried out by promoting demand-driven Knowledge Management function, establishing a more flexible policy and norms for fur management to achieve results and to build IP capacity on Results Based management.
	7. The independent review of the "Support for Upscaling Jadelle Roll-Out in the Solomon Islands 2016-2019 was carried and finalized in May 202 The review highlighted programming issues and proposed that the programme's Theory of Change be reviewed to consider gaps in programmin for any future programme design and stressed that monitoring, reporting and learning should be strengthened, with additional support fro UNFPA PSRO.

	8. The end of programme evaluation of the Pacific Sexual and Reproductive Health Programme (PRSRHP) 2014-2020 was conducted by an independent consultant in September 2020. The evaluation outlined the need to continue implementing programmes like PRSRHP, PSRO would need to develop an MEL institutional culture and ensure sound MEL systems, products, tools, and capacity are developed and embedded in the organization, as well as used to strengthen MEL among Ministries and IPs.
	9. The Mid-Term Review of the Transformative Agenda for Women, Adolescents and Youth in the Pacific: Towards Zero Unmet Need for Family Planning for the period 2018-2022 was conducted in 2020. The review highlighted that the Monitoring and evaluation framework be revised to ensure that the results indicators are included and measurable; that relevant FP data can be collected and reported by the MOH Health Information Systems (HIS); and that the strategic interventions are allocated indicators to ensure advancement of these activities. It outlined that some indicators may require national tailoring to accommodate differences in SRH data currently collected by the country-level HIS.
	10. This MCPD7 and its costed evaluation plan also take into account findings and recommendations of the recent global and thematic evaluations such as "Evaluation of UNFPA support to the prevention, response to and elimination of gender based violence and harmful practices 2012-2017", Formative evaluation of UNFPA support to adolescents and youth Evaluation of UNFPA support to gender equality and women's empowerment (2012-2020) and "Developmental evaluation of results-based management at UNFPA 2019" conducted by the Evaluation Office.
	11. The costed evaluation plan also takes into account the guidelines provided in the UNFPA Quadrennial Budgeted Evaluation Plan 2022- 2025 in line with the UNFPA Strategic Plan 2022-2025 and UNFPA Evaluation Strategy 2022-2025 to enhance the use of evaluations.
	12. To roll out the costed evaluation plan, UNFPA will consider partnerships with major PICT stakeholders, including government departments, civil society organizations, academia and research institutions, among others, to ensure the credible and timely country-led evaluations as listed below. In addition, UNFPA will also engage in partnerships to enhance the evaluation capacities of young evaluators and also support the national evaluation capacity development (NECD) through establishment of voluntary organizations for professional evaluation (VOPE).
	13. In addition, other training activities to build in-country capacities of both UNFPA field staff and implementing partners have been incorporated into the plan, including trainings that are in line with the NECD initiative, as well as towards achieving increased national evaluation capacities to help countries monitor their programmes and plans to achieve the SDGs, as per UNFPA's IEO intentions for the Decade of Evaluation.
