The evaluations included in the CEPlan, including the country programme evaluation (CPE), are designed to address these gaps, providing critical evidence to accelerate progress towards UNFPA's transformative results. For Output 1, existing evaluations show significant progress in expanding statistical tools to include ethnic self-identification and disability due to UNFPA's advocacy and support for censuses and nati

the interoperability of diverse data systems. Furthermore, there is limited evidence on what type of advocacy and policy efforts are effective, and under what conditions, to drive the use of data in decision-making at the national and sub-national levels. Although Panama has made progress in generating disaggregated data, evaluations have revealed persistent challenges in the sustainability and institutionalization of these achievements. More evaluative evidence on what works to sustain these gains is needed. Moreover, evaluations do not clearly identify effective strategies to address weaknesses in data systems and their use, or those that contribute to improving demographic resilience in diverse contexts.

To address these evidence gaps, the CPE (2026-2030) will examine the effectiveness, efficiency, and sustainability of UNFPA's contributions to strengthening the national data ecosystem and promote the use of data in policy-making across Panama. In addition, the evaluation of the UNSDCF evaluation (2026-2030) will be a key source of evidence. The evaluation will assess the collective contribution and synergies of UN system-wide initiatives aimed at strengthening Panama's national data ecosystem. This will include analyzing inter-agency efforts on data interoperability, the digitalization of administrative records, and joint advocacy for the use of evidence in policy-making. The evaluation will provide crucial information on UNFPA's strategic role and added value within these collaborative efforts.

For **Output 2**, critical gaps in evaluative evidence persist regarding sexual and reproductive health and family planning services for adolescents and youth. While UNFPA has supported out-of-school comprehensive sexuality education through its Adolescent-Friendly Health Services model, more rigorous evidence is needed to assess its effectiveness as a sustainable public policy model in Panama.

The evaluation of the project "Strengthening Adolescent-Friendly Services (AFHS) with an Emphasis on Tobacco Prevention" will address this gap by assessing if the model is an effective and sustainable alternative strategy for delivering essential sexual and reproductive health services and comprehensive sexuality education to adolescents and youth outside of the formal school system. This evaluation will also explore how the model addresses underlying factors like discriminatory gender norms and will examine the growing resistance to rights-based programming.
