INTRODUCTION

Access to reproductive health, including family planning, is recognized as a human right. Yet the importance of a steady and reliable supply of contraceptives is often overlooked as a priority on the development agenda. External procurement support is critical to improving and ensuring the security of essential contraceptives and other life-saving reproductive health commodities. Many developing countries plan to strengthen and improve contraceptive security. However, these countries are still largely reliant on aid from external partners and organizations in order to help keep pace with needs in their countries, which may vary according to the population dynamic unique to each country.

In 2012, the London Summit on Family Planning inspired global momentum to extend the benefits of universal rights-based voluntary planning to poor and marginalized women and girls. The contraceptives procured by donors are tremendous contribution to reproductive health, including family planning, and yet there is much to be done. At least 222 million women in developing countries have an unmet need for family planning, meaning they want to avoid pregnancy but are not using modern contraceptives. In sub-Saharan Africa alone, 58 million women have an unmet need for family planning and, in the region's 39 poorest countries unmet need has actually

increased since 2008. It is within the context of this unmet need that the importance of the external procurement support for procurement of contraceptives and condoms for dual protection must be viewed. In 2012, the nine donors and partners covered in this report procured contraceptives and condoms valued at \$321 million, an increase of \$11.9 million from 2011. The essential supplies reached 147 countries, up from 142 the previous year.

About the report

UNFPA, the United Nations Population Fund, has issued this annual report since 1997, and has been tracking activities around donor support since 1990. This year, the title has changed from 'donor support report' to the more precise 'external procurement support report'. The revised title is Contraceptives and Condoms for Family Planning and STI/HIV Prevention: External Procurement Support Report 2012. The report was prepared and published by the Commodity Security Branch, Technical Division, UNFPA New York, in conjunction with the Procurement Services Branch in Copenhagen.

Objectives

The goal is to track, analyse and document the external procurement support dynamics over a broad range of modern contraceptive options for family planning and STI/HIV prevention programmes in developing countries. For UNFPA, donors and partners, this report provides an overview of the current support level versus historical trend. This perspective enables relevant parties to gain a better sense of the overall effort towards serving the goal of improved family planning and STI/HIV prevention in developing countries. As such, the report strives to meet a number of objectives including:

- Collecting, compiling and analysing distribution of funds by region;
- Donor contribution trend analysis, including a breakdown by nine providers of external procurement support:
 - 1. Department for International Development (DFID)
 - 2. The Global Fund to Fight AIDS, Tuberculosis and Malaria
 - 3. International Planned Parenthood Federation (IPPF)
 - 4. Marie Stopes International (MSI)
 - Population Services International (PSI)
 - United Nations Population Fund (UNFPA)
 - United States Agency for International Development (USAID)
 - 8. German Development Bank (KfW)
 - 9. DKT International (DKT)

- Allow for a holistic overview of external procurement support in order to identify and share gaps and visualize commodity security trends and financial resource allocation;
- Aid in validating future funding needs for the advancement of reproductive health commodity security in the realm of policy dialogue, advocacy and inter-agency collaboration.

Unit of measurement

The reproductive health commodities in this report are quantified by distinct units of measurement:

Methodology

Data collection

Since 1990, a database compiled by UNFPA has tracked more than 20,000 procurement records of contraceptives and condoms for STI/HIV prevention by major bilateral, multilateral and social marketing organizations and NGOs. The database is updated annually on the basis of this report.

Each year, by the end of first quarter, UNFPA requests data from the major donors/partners. The report uses the latest data received from the individual donors and partners about the support they have provided directly to the countries for the procurement of contraceptives and condoms. We have, over the years, established communications with focal points within respective donors/partners who provide us with the data on an annual basis.

Data analysis

All primary data are analysed upon collection from the donors. It is important to point out that the analysis results may vary from year to year. Donors may on occasion amend previous data, perhaps due to a variation in conversion factors from the current year to previous years. In effect, the report would incorporate such a change in methodology, with the database updated accordingly.

It is also important to point out that this report does not take into account data from the private sector, in-country local procurement and procurement activities financed by the World Bank. Furthermore, other donors beyond those covered in this report also contribute to family planning in the form of commodity procurement, but this information is not readily accessible and therefore, falls outside the scope of this report. Also, this report does not distinguish between the dual purpose of condom use for the prevention of unintended pregnancy as well as HIV infection.

We understand that many large donors, in addition to their direct support to countries, do provide funding support to UNFPA and others. However, in this report all resources received by UNFPA from various donors for RH commodities are listed as UNFPA support, because it is difficult to separate them.

Over the years this report also reflected support from organizations like MSI, PSI, DKT, etc. For these implementing organizations, the report only takes into consideration funds that are mobilized or raised by them from different private donors, foundations, etc. Figures on funding are carefully reviewed during the data analysis period and several bilateral communications are made to validate and exclude any overlapping and/or double reporting with major donors. Also any resources generated through sales proceeds are also excluded. For example, the 2012 figures of DKT (\$8 million) or MSI (\$2.8 million) represent resources mobilized by these organizations.

Report drafting process

Upon data collection from the donors, UNFPA verifies that the data include all five categories of: (i) country names in which commodities were sent; (ii) type of contraceptive and condom; (iii) unit price; (iv) total quantity; and (v) net total cost. Once this is verified, the data figures are reviewed in order to avoid possible duplication. Data figures compiled by UNFPA are then sent back to the respective parties for final validation. A draft version of the report is circulated amongst the appropriate reviewers for feedback and finalization approval. Once the report is finalized, it is published and circulated to the wider audience via email and also made publicly accessible through the UNFPA website.

Geography and date range

For the purpose of this report, countries were grouped into the following four regions according the functional regions of UNFPA:

- Africa: All sub-Saharan countries;
- Arab States: Includes Northern African countries and countries from the Middle East, Eastern Europe and Central Asia;
- Asia and the Pacific: Includes countries from Asia and the Pacific Islands; and
- Latin America: Includes countries from Latin America and the Caribbean.

The reporting period is a calendar year, 1 January to 31 December 2012.



TREND ANALYSIS

Sustained support enables developing countries to achieve national goals towards improved family planning and STI/HIV prevention. In 2012, external procurement support for contraceptives and condoms went to a total of 147 countries, an increase from 142 countries in 2011. Fifty-five countries received support in Africa, 35 countries in Asia and the Pacific, 24 countries in the Arab States, and 33 countries in Latin America and the Caribbean.

The total value of donor support for contraceptives and condoms for family planning and STI/HIV prevention was more than \$321 million in 2012 (Table 1). This was an increase of \$11.9 million from the previous year in which a total of over \$309 million in donor support was provided, or a 4 per cent growth (Table 2).

At the global level, support decreased among five of the seven donors/partners. Most significantly, KfW reduced its support by nearly \$8.5 million, a decrease of 36 per cent, followed by PSI, which reduced its support by over \$6 million, or a decrease of 18 per cent. USAID, DFID and MSI reported a reduction in support of nearly \$18.7 million (15 per cent), \$1.2 million (9 per cent), and \$27,000 (1 per cent), respectively.

It is also important to note that among the listed donors/partners, PSI and DKT are social marketing organizations. As such, they generate revenues through the sales and proceeds of commodities, and then utilize these revenues for replenishment and re-supply.

Support from The Global Fund, UNFPA and IPPF increased by 26 per cent, 45 per cent, and 48 per cent, respectively. In addition, implants have also enjoyed positive growth in 2012, as have injectables and IUDs. The commodity mix in contraceptive and condom type is provided below (Table 3).

Male condoms received the highest support in monetary value, accounting for about 30 per cent of the total commodity mix. This was followed by implants that made up about 24 per cent; injectables at 21 per cent; oral pills at 14 per cent; female condoms at 6 per cent; and IUDs, emergency contraceptives and others at 1 per cent of the total.

A volume comparison between 2011 and 2012 reveals that, overall, many of the major commodities declined in volume distributed (Table 4).

Implants benefited from a significant distribution increase of nearly 64 per cent from 2011 to 2012. IUDs also experienced a positive increase of 36 per cent. This was followed by injectable contraceptives with a 6 per cent increase.

All remaining commodities experienced a decline with the sharpest being female condoms at negative 27 per cent; next with male condoms at negative 8 per cent; followed by oral pills and emergency contraceptives at negative 5 per cent and negative 4 per cent, respectively. However, it is important to note that the 2012 quantities do not include quantities from DKT, whereas the 2011 does include quantity figures from DKT.

From a regional distribution level, positive growth was only observed in Africa and the Arab States. In contrast, expenditure decreased in Asia and the Pacific and in Latin America and the Caribbean (Table 5).

Consistent with trends in the past, the majority of external procurement support was geared towards the African region, which accounted for 67 per cent of the total transaction for 2012. Africa also received a positive growth from 2011 to 2012 of 19 per cent in total transaction amount.

Trend analysis over seven years




Figure 1: Support trend for contraceptives and condoms, 2006-2012

Overall, external procurement support has remained strong over the past seven years. The top two largest recorded contributions to contraceptives and condoms for family planning and STI/HIV prevention belong to USAID and UNFPA (Figure 1). USAID provided \$124 million in 2011. UNFPA then surpassed this record with a contribution of \$128 million in 2012. UNFPA expenditure from 2011 to 2012 increased by \$39.5 million.




Figure 2: Support trend by region, 2006-2012

From a regional perspective, Africa has received the highest support year after year from 2006 to 2012 (Figure 2). With the exception of 2008 and 2010, support has remained strong with positive growth. Apart from the African region, Asia and the Pacific have received the second-highest level of support, which was followed by Latin America and the Arab States. Further details on historical trends by family planning commodities are provided in Section 6 of this report.

CONTRIBUTIONS IN 2012

In this section, the individual contributions by each of the donors and partners covered in this report are highlighted and support is defined in terms of finance, region and quantity.

Department for International Development, UK

DFID, providing United Kingdom aid from the Department for International Development, demonstrated its continued commitment to improving the lives of girls and women through family planning. The overall support by DFID for the procurement of contraceptives and condoms increased dramatically in 2012. DFID made a contribution of \$62.7 million to UNFPA towards supporting countries with implants and female condoms. In the present report, the DFID contribution is included within UNFPA expenditures, accounting for nearly half of UNFPA support this year. Consistent with previous years, in 2012 DFID provided direct support of nearly \$11.3 million, which was \$1.2 million less than in 2011. Globally, DFID is one of the largest donors in reproductive health commodity security, providing support through channels outside the scope of the present report.

In addition to DFID support through UNFPA for implants and female condoms, direct contributions for external procurement in 2012 focused on the following four commodities: male condoms, oral pills, injectables and implants. According to the data received, the commodity distributions were to four countries: Cambodia, Nigeria, Uganda and Zimbabwe. Among these four countries, Nigeria received the highest level of support at \$3.9 million worth of male condoms and nearly \$3.6 million worth of injectable contraceptives, which totalled nearly \$7.5 million. The commodity distribution breakdown follows (Table 7).

The top three commodities supported by DFID were male condoms, injectable contraceptives and implants. The top two commodities combined accounted for over 80 per cent of expenditures from DFID.


- Male condoms accounted for 41 per cent of total support, consistent with support in the previous year. Male condom support remained relatively stable;
- For injectable contraceptives, support also equally accounted for 41 per cent of support. A significant growth was seen in injectables this year;
- Implants accounted for 10 per cent of support.

By region, DFID directed the majority of its commodity support – some 94 per cent – to countries in Africa, with the remaining 6 per cent going to Asia and the Pacific.

3.2 DKT International

DKT is one of the largest social marketing providers of family planning and reproductive health products and services in the developing world. As an organization (non-profit), DKT mobilizes resources from different donors, procures commodities for different countries and generate revenues through their sale proceeds. DKT's contribution for 2012 totalled \$8 million, with \$7 million allocated to Ethiopia and the remaining \$1 million distributed among several other countries, namely, the Democratic Republic of the Congo, Ghana, India, Indonesia, Mozambique and Sudan. Various commodities were provided to all countries but the exact product mix breakdown was unavailable for 2012.

In addition to the amount DKT mobilized in 2012 as external procurement support, it also contributed commodities procured with sales revenues generated through it social marketing activities.

3.3 The Global Fund

The Global Fund provided resources to procure both types of condoms (male and female). The commitment towards HIV prevention remained strong with about \$14.5 million of expenditure recorded in 2012. This category of commodity was in support of more than 39 countries with a regional breakdown as follows (Table 9).


Through The Global Fund, 95 per cent of monetary support was spent on male condoms in 2012 with a quantity of nearly 343 million pieces procured. The remaining 5 per cent was spent on female condoms for some 884,000 pieces (Table 9).

A total of 39 countries received support for male and female condoms. Of these countries, 38 countries received male condoms: 10 in Africa, eight in Asia and the Pacific, nine in the Arab States and 11 in Latin America and the Caribbean.

In the Africa region, Tanzania received the highest quantity of male condoms at nearly 62 million pieces. This was followed by Ethiopia with 46.5 million pieces and Burundi with 3.5 million pieces. For Asia and the Pacific, the highest quantity went to Bangladesh at 19 million pieces, followed by Indonesia with nearly 17 million pieces and Myanmar with 9 million pieces. For the Arab States, Ukraine received the highest with nearly 25 million pieces, followed by Kazakhstan with 9 million pieces and Belarus with nearly 2.7 million pieces. Lastly, in the Latin America region, Mexico received the highest support with 53 million pieces and was followed by Colombia and Nicaragua with nearly 16 million and 10 million pieces, respectively.

In contrast, female condoms were distributed to only a handful of countries, including four countries in Africa, two countries in Asia and the Pacific and two countries in Latin America. In the Africa region, Uganda received the highest with 200,000 pieces, which was followed by Guinea and Mauritius with 25,000 pieces and Niger with 10,000 pieces. For Asia and the Pacific, Myanmar received 53,000 pieces and Nepal received 1,000 pieces. Lastly, in the Latin America region, El Salvador received 500,000 pieces and Mexico received almost 70,000 pieces.

The majority of support was directed towards Latin America and the Caribbean (Table 10). In 2012, The Global Fund was the only donor that focused the majority of its expenditure on this region (43 per cent) (Figure 4). This is consistent with past data, e.g. this region received 46 per cent of The Global Fund's support in 2011.

3.4 International Planned Parenthood Federation (IPPF)


IPPF strives for a world in which women, men and young people have better access to sexual and reproductive health, which can help lead to better family planning. This commitment translated to more than \$6 million in support for a spectrum of commodities related to reproductive health in 2012. This is a positive signal in that this was an increase of \$2 million over the 2011 contribution of \$4 million — one and a half times the level of support.

As seen in Figure 5, IPPF's highest support for 2012, in terms of monetary value, was in oral pills (30 per cent). This was followed by injectable methods at 27 per cent; implants at 21 per cent; male condoms at 13 per cent; IUDs and others at 3 per cent; female condoms at 2 per cent and emergency contraceptives at 1 per cent.

It is also important to note that not all of the commodities procured by IPPF were distributed to the countries directly, but a portion was kept in stock as well, some \$1.7 million worth of commodities (Table 12).

IPPF distribution reached a total of 82 countries in 2012. Of this number, 36 African countries were supplied with contraceptives and condoms, followed by 24 countries in the Latin America region, 21 countries in the Asia and the Pacific region and two countries in the Arab States region.

The top three commodities supported by IPPF were oral pills, injectable contraceptives and implants. The top four countries receiving support for quantities of these family planning supplies were as follows:

- For oral pills, Sri Lanka (2,016,000 cycles), Burkina Faso (429,000 cycles); Surinam (205,260 cycles) and Malaysia (101,520 cycles);
- For injectables, Sri Lanka (201,000 vials), El Salvador (100,800 vials), Mauritania (100,000 vials) and Panama (38,250 vials); and
- For implants, Sri Lanka (3,000 sets), Peru (2,100 sets), Benin (1,500 sets) and Zambia (1,160 sets).


By region, the commodity distribution breakdown for these methods (oral pills, injectables and implants) was as follows, for the top three countries in each region:

- For the Africa region, the most support for oral pills went to Burkina Faso (429,000 cycles); for injectables, to Mauritania (100,000 vials); and for implants, to Benin (1,500 sets);
- For the Asia region, Sri Lanka received the most support for all three methods: oral pills (2,016,000 cycles), injectables (201,000 vials) and implants (3,000 sets);
- For the Arab States region, the most support for oral pills went to Morocco (93,600 cycles); for injectables, also to Morocco (1,000 vials); and there was no support for implants in the region;
- For the Latin America region, the most support for oral pills went to Surinam (205,260 cycles); for injectables, to El Salvador (100,800 vials) and for implants, to Peru (2,100 sets).

Overall, IPPF appeared to have an even split among all the major regions (Africa, Asia and the Pacific and Latin America), with less support directed towards the Arab States region (Figure 6).

3.5 KfW

KfW, the Federal Republic of Germany through KfW Entwicklungsbank (the German development bank), provided nearly \$15.2 million for family planning commodities. This was a decrease of \$8.3 million in support compared to 2011. Commodities included male and female condoms, oral pills, emergency contraceptives, injectables, IUDs and implants (Table 14). Support was given to a total of 19 countries with the majority allocated to the Africa region (65 per cent). This was followed by the Arab States region with 32 per cent and Latin America with 3 per cent (Figure 7).

The majority of commodity distribution focused on male condoms at 62 per cent of the total value. This was followed by injectables and oral pills at 17 and 12 per cent, respectively. This was a significant shift from 2011, when male condoms and implants received nearly proportional support of 37 and 35 per cent, respectively. Injectables and oral pills more or less followed a similar pattern from 2011 to 2012.

The top three commodities included male condoms, injectables and oral pills:


- For male condoms, the majority of support went to Pakistan with \$2,775,474 worth of the commodity. Cameroon received \$2,166,708 and Mali received \$874,996 worth of the commodity;
- For injectables, Pakistan was the highest recipient with \$726,750, followed by Burundi at \$566,100 and Guinea at \$393,096;
- For oral pills, the highest recipient was Mali with \$429,083. This was followed by Côte d'Ivoire and Guinea at \$410,248 and \$367,277, respectively.

The highest recipient of IUDs was Pakistan with \$589,908, followed by Burundi with \$30,150 and Yemen with \$24,622. For implants, the highest level of support went to Ghana with \$372,000. This was followed by the Dominican Republic and Benin with \$54,000 and \$24,525, respectively. For female condoms, only two African countries received support: Burkina Faso with \$86,030 and Guinea Bissau with \$1,380 worth of the commodity. For emergency contraceptives, Côte d'Ivoire received the highest support with \$57,672. This was followed by Dominican Republic with \$6,000 and Benin with \$4,260.

Among the 19 countries that received support, 15 countries were from Africa, two from the Arab States, one from Asia and one from the Latin America region. Similar to the previous year in 2011, the highest recipient in terms of monetary support was Pakistan, which received nearly \$4.3 million. This was followed by Cameroon, which received nearly \$2.2 million worth of commodities (male condoms).

3.6 Marie Stopes International (MSI)

MSI is one of the largest international family planning non-governmental organizations (NGOs) and their activities encompass clinical outreach, social franchising, safe abortion, HIV/STI prevention and treatment, maternal health and centres (static clinics) located in many countries where they are operational. In 2012, MSI provided a little over \$2.8 million of contraceptive commodities that included implants, injectables, IUDs, male condoms and oral pills (Table 16). Support was given to a total of 13 countries with the overall majority in the Asia and the Pacific region (60 per cent) (Figure 8). This represented a significant change in the level of support allocated to Asia and the Pacific, up from 47 per cent in 2011 to 60 per cent in 2012.

The recipient countries in Asia and the Pacific included Afghanistan, Mongolia, Myanmar, Nepal, Pakistan, Papua New Guinea and the Philippines. In Africa, they were Kenya, Malawi, Sierra Leone and Zimbabwe. One country in the Arab States (Yemen) and one in the Latin America region (Bolivia) also received support in 2012.

MSI devoted the majority of its commodity support to male condoms, which amounted to 40 per cent of the total support value. This was followed by implants, which accounted for 26 per cent; oral pills at 25 per cent; injectables at 6 per cent and IUDs at 3 per cent (Table 16).

The top three commodities included male condoms, implants and oral pills:

- For male condoms, the majority of support went to Malawi with \$337,840 worth of the commodity. This was followed by Pakistan with \$249,500 and Mongolia with \$233,625 worth of the commodity.
- For implants, Malawi was the highest recipient with \$189,400 followed by Pakistan at \$172,800 and Bolivia at \$142,450.
- For oral pills, A high concentration of the oral pills went to Asia and the Pacific with Myanmar receiving \$577,750 worth of oral pills, followed by Mongolia with \$89,987 and Afghanistan with \$19,000.


Only two countries received support for injectable contraceptives – Myanmar with \$26,000 and Yemen with \$152,505. Lastly, IUDs were distributed to all the regions, with Asia and the Pacific receiving the most.

The Philippines received the highest level of support with \$17,690, followed by Pakistan with \$11,700 and Afghanistan with \$7,400. In addition, Yemen in the Arab States region received \$27,510, Bolivia in the Latin America region received \$8,000, and Zimbabwe in the Africa region received \$350 worth of IUDs.

3.7 Population Services International (PSI)

PSI is a leading global health organization that targets malaria, child survival, HIV and reproductive health. In the area of reproductive health, PSI contributed approximately \$30 million in family planning commodities to 28 countries in 2012.

As seen in Table 18, globally there was a slight decrease in support value from 2011 to 2012. While the highest support went to male condoms (72 per cent of the total net support value), this was a slight drop from approximately \$29 million in 2011 down to \$21 million in 2012. Oral pills, emergency contraceptives, injectables and IUDs benefited with positive growth. Less support was directed in 2012 to other commodities such as female condoms and implants.


The regional breakdown includes 15 countries in Africa, six countries in Asia and the Pacific, and seven countries in Latin America.

The Africa region received 68 per cent of the total support value with the majority of support going to South Africa (\$6.6 million) and Tanzania (\$6.3 million). Kenya received well over \$4.4 million and Guinea received over \$1.6 million worth of support as well. The remaining countries of Angola, Benin, Cameroon, Madagascar, Mali, Nigeria, Rwanda, Somaliland, Uganda, Zambia and Zimbabwe received various level of support below \$1 million. In Asia and the Pacific, Pakistan received the highest support with nearly \$6.8 million. This was followed by India with over \$1 million and Cambodia with \$484,000. In the Latin America region, Paraguay received the highest support in the amount of \$345,000. This was followed by Central America with \$286,000 and Guatemala at \$219,000.

3.8 United Nations Population Fund (UNFPA)

UNFPA's goals include achieving universal access to sexual and reproductive health by supporting family planning, promoting reproductive rights, reducing maternal mortality and accelerating progress on the Programme of Action of the International Conference on Population and Development (ICPD) and Millennium Development Goal 5 (MDG5). UNFPA continued to work with partner governments, non-governmental organizations and donors to expand access to voluntary family planning information and services within the context of sexual and reproductive health and reproductive rights.

In 2012, through its flagship thematic fund, the Global Programme to Enhance Reproductive Health Commodity Security (GPRHCS), UNFPA mobilized additional resources, which were spent in support of country capacity building initiatives and the procurement and delivery of reproductive health commodities. The majority of these financial resources were provided by the Department for International Development of the United Kingdom (DFID), The Ministry of Foreign Affairs of the Netherlands and the European Commission. In addition, smaller contributions were also received from other countries and private donors.

2012 marked a year in which UNFPA reported a significant surge in support for implants and emergency contraceptives inclusive of a \$62.7 million contribution from DFID for expenditure through UNFPA. Implants nearly tripled in support value from 2011 to 2012 and emergency contraceptives nearly doubled (Table 17). On the other hand, support for female condoms decreased approximately 32 per cent from 2011 to 2012. All other remaining modern contraceptive commodities benefited from positive growth from 2011 to 2012.



Commodities support was given to a total of 110 countries. Similar to other major donors and partners, the majority of UNFPA's support focused on the Africa region (69 per cent) (Figure 10). This equates to over \$88 million worth of commodities supplied to the region. This was followed by Asia and the Pacific, which received over \$16 million worth of commodities, and Latin America with over \$12 million. The majority of the support remained focused in Africa.

3.9 United States Agency for International Development (USAID)

USAID offers assistance in a broad spectrum of key areas, including 'global health' and more specifically in family planning. In 2012, USAID provided over \$105 million worth of family planning commodities to 40 countries (Table 22). However, this was a decline of 15 per cent from the previous year. Overall support in commodities decreased from 2011 to 2012 across all family planning commodities.

In Africa, Ethiopia received the highest support in the amount of \$11.8 million that consisted of implants, oral pills, injectables and male condoms. This was followed by Uganda with \$10.2 million worth of support that consisted of IUDs, implants, oral pills, injectables and male condoms. Nigeria received the third highest amount of support at \$9.3 million, which consisted of implants, IUDs, injectables and oral pills.

In Asia and the Pacific, Pakistan received the highest support in the amount of \$11.8 million that consisted of implants, IUDs, injectables, oral pills and male condoms. This was followed by Bangladesh with \$4.7 million for implants, oral pills, injectables and male condoms. Thirdly, Afghanistan received \$2.7 million of support that consisted of IUDs, injectables, oral pills and male condoms.

In the Arab States region, Georgia received \$190,800 in commodities support, which consisted of IUDs, oral pills and male condoms. Jordan received \$98,500 for implants and injectables.


In the Latin America region, Haiti recorded the highest level of commodities support with \$2.7 million that consisted of implants, oral pills, injectables and male condoms. This was followed by the Dominican Republic with \$753,000 for male condoms. Trinidad and Tobago received \$209,000 for male and female condoms.

In 2012, the majority of USAID's support was directed towards 24 countries within the African region, which accounted for 76 per cent of the total expenditures for the year. Nine countries received support in Asia and the Pacific with 20 per cent of the total value spent, followed by five countries in the Latin America region with 3 per cent of total support. In addition, two countries in the Arab States region received some support (Figure 11).

MALE AND FEMALE CONDOMS

Contributions for male condoms amounted to 3.08 billion pieces in 2012. The record for male condoms was 3.36 billion pieces in 2011. This translates to a 9 per cent decrease from 2011 to 2012 for the nine providers of external procurement support featured in this report.

In terms of female condoms, the net amount totalled nearly 31.8 million pieces for 2012. This was a 24 per cent decrease from nearly 43.4 million pieces in 2011.




Figure 12: Quantity of male condoms by region and by donor/partner, 2012

USAID, UNFPA and PSI provided the highest overall quantity of male condom pieces (Figure 12). PSI, USAID, UNFPA, KfW, DFID and The Global Fund primarily supplied male condoms to Africa, which received 55 per cent of all male condoms provided. USAID was the leading donor of male condoms in 2012 with more than 802 million pieces, followed by PSI with more than 725 million pieces and UNFPA with more than 690 million male condoms (Table 26).

UNFPA and USAID were the largest suppliers of female condoms to all regions (Figure 13). UNFPA provided the highest quantity of female condoms with approximately 20.3 million pieces, followed by USAID with 10.3 million pieces, and The Global Fund with more than 880,000 pieces. Africa secured the biggest contribution at 25.7 million pieces out of 31.7 million total pieces, about 81 per cent (Table 27).



Figure 13: Quantity of female condoms by region and by donor/partner, 2012









Figure 16: Expenditure split, condoms versus other contraceptives, 2006-2012

Figure 17: Proportion of expenditure support, 2012




Figure 18: Proportion of expenditure for male condoms, 2012



Figure 19: Proportion of expenditure for female condoms 2012







Figure 21: Proportion of expenditure for emergency contraceptives, 2012

Figure 23: Proportion of expenditure for IUDs, 2012



