Sociopolitical context


Uganda continues to face an ongoing influx of refugees from neighbouring countries, particularly the Democratic Republic of the Congo and South Sudan. These population movements have increased pressures on existing resources and public services. The country is grappling with food insecurity exacerbated by climate change, economic instability and infrastructural deficits. Various health concerns, including outbreaks of diseases and the impacts of the COVID-19 pandemic, pose ongoing risks to the population.

FGM context

female genital mutilation (FGM) is practised mainly among the Pokot, Sabiny, Tepeth, and Kadam communities in eastern Uganda, specifically in the Bugisu and Karamoja regions bordering Kenya. There are reports of FGM in Kampala and some districts hosting refugees from Eritrea, Ethiopia, Somalia and Sudan.

Spotlighted interventions

Expanding and intensifying the global influence of the Joint Programme

Uganda's leadership and collaboration with the East African Community and East African Legislative Assembly shaped policies and legal frameworks for cross-border FGM elimination. High-profile events, including the Zero Tolerance Day Symposium and cultural festivals, have provided international platforms to showcase Uganda's progress and challenges, drawing attention and support. Strategic partnerships with development agencies such as the International Development Law Organization and the Austrian Embassy have bolstered the visibility and credibility of the Joint Programme, reinforcing its role as a key player in the global movement to end FGM.

The Joint Programme partners with government initiatives, such as the Parish Development Model and financial inclusion programmes within community interventions, including adolescent clubs and community groups. This opens long-term economic alternatives for vulnerable girls and women, and strengthens the resilience of individuals and families. In 12 clubs in the districts of Amudat, Kween, Bukwo, Moroto, Nakapiripirit and Kapchorwa, 350 young women gained livelihood training and village savings and loan associations. An additional 350 trained adolescents started livelihood-generating activities (vegetablegrowing, poultry-raising) to support education costs. Sanitary pads and scholastic materials were provided as well as peer support to mobilize girls to return to and stay in school.
