SECRETARY GENERAL OF THE CONFERENCE

I BRING TO YOU THE GREETINGS OF THE INTERNATIONAL LABOR ORGANIZATION,
AND ITS DIRECTOR GENERAL, MR. MICHEL HANSENNE. I WISH TO TAKE THIS
OPPORTUNITY TO EXTEND TO YOU, MR. PRESIDENT, MY PERSONAL BEST WISHES FOR
THE CHALLENGING WORK AHEAD OF US.

MR. PRESIDENT,

THIS INTERNATIONAL CONFERENCE ON POPULATION AND DEVELOPMENT COINCIDES WITH THE 75TH ANNIVERSARY OF THE FOUNDING OF THE INTERNATIONAL LABOR ORGANIZATION AND THE 50TH ANNIVERSARY OF THE DECLARATION OF PHILADELPHIA WHICH SET OUT THE ORGANIZATION'S FUNDAMENTAL OBJECTIVES. THE DIRECTOR GENERAL, MICHEL HANSENNE, CHOSE AS THE ORGANIZING CONCEPT FOR THIS OCCASION "DEFENDING VALUES, PROMOTING CHANGE". I CANNOT FIND A MOTTO MORE FITTING FOR THIS CONFERENCE.

IN REVIEWING THE PLAN OF ACTION BEFORE THIS CONFERENCE, I COULD NOT HELP BUT BE STRUCK BY THE COMMONALITY OF ITS OBJECTIVES AND THOSE OF THE ILO, AND THE EMPHASIS IT PLACES ON ILO CONCERNS OF SOCIAL JUSTICE AND POVERTY ALLEVIATION.

FIFTY YEARS AGO, THE DECLARATION OF PHILADELPHIA AFFIRMED: " ALL HUMAN BEINGS, IRRESPECTIVE OF RACE, CREED OR SEX, HAVE THE RIGHT TO PURSUE BOTH THEIR MATERIAL WELL-BEING AND THEIR SPIRITUAL DEVELOPMENT IN CONDITIONS OF FREEDOM AND DIGNITY, ECONOMIC SECURITY AND EQUAL OPPORTUNITY". THS OBJECTIVE CAN ONLY BE MET IN A SUSTAINABLE MANNER THROUGH PRODUCTIVE, FREELY CHOSEN EMPLOYMENT. HOWEVER THE PROBLEM OF UNEMPLOYMENT HAS REACHED THE SAME HIGHTS OF THE GREAT DEPRESSION, AND AS WE REACH THE END OF THE CENTURY, THE ILO ESTIMATES THAT ABOUT 40 MILLION NEW JOBS WILL NEED TO BE CREATED EVERY YEAR TO ABSORB THE WORLD'S INCREASING LABOR FORCE.

AGAIN, THE DECLARATION OF PHILADELPHIA STATED THAT "POVERTY ANYWHERE CONSTITUTES A DANGER TO PROSPERITY EVERYWHERE". I NEED NOT REMIND, THIS GATHERING THAT ABOUT 1.2 BILLION, OR ONE FIFTH OF THE WORLD'S POPULATION LIVES IN ABSOLUTE POVERTY. AS STATED IN THE DOCUMENT BEFORE US, THE DEVELOPMENT CHALLENGE IS TO MEET THE NEEDS AND IMPROVE THE QUALITY OF LIFE OF PRESENT AND FUTURE GENERATIONS. POPULATION ISSUES ARE PLACED IN THE WIDER PERSPECTIVE OF THE NEED FOR A MORE PEOPLE-CENTERED DEVELOPMENT AND THE ALLEVIATION OF POVERTY. THIS APPROACH TO DEVELOPMENT COINCIDES WITH THAT OF THE ILO WHICH HAS ALWAYS BEEN FOCUSED ON SOCIAL PROGRESS AND QUALITY OF LIFE SIDE BY SIDE WITH GROWTH AND EFFICIENCY.

MR. PRESIDENT,

HAVING LISTENED TO THE MANY DISTINGUISHED PARTICIPANTS WHO HAVE TAKEN

THE FLOOR BEFORE ME, I CAN SAY THAT THREE CLEAR MESSAGES EMERGE:

FIRST, THAT THE TIME HAS COME FOR LESS TALKING AND MORE ACTION. WE OWE
IT TO OURSELVES NOT TO ALLOW THIS GATHERING TO BE "YET ANOTHER
CONFERENCE", A "TALKING SHOP".

SECONDLY, WHILE. THERE IS UNIVERSAL ACCEPTANCE OF THE NEED FOR

ACTION, IT IS CLEAR THAT THE APPROACH TO POPULATION AND DEVELOPMENT MUST

RESPECT THE CULTURAL, HISTORICAL AND SPIRITUAL SPECIFICITY OF EACH

COUNTRY.IN THIS RESPECT, I CAN ONLY UNDERLINE THE WORDS OF PRESIDENT

MUBARAK WHEN HE SAID "THIS CONFERENCE COMBINES PEOPLE OF DIFFERENT

CIVILIZATIONS, CULTURES, AND HEAVENLY MESSAGES WHOSE LAWS SHOULD BE

RESPECTED.HENCE, THERE IS NO OTHER WAY BUT AN INTERACTION OF OPINIONS

IN AN ATMOSPHERE OF DEMOCRACY, IN A BID TO FIND A COMMON DENOMINATOR

THAT UNITES US WITHIN THIS RICH MISCELLANEOUS GATHERING"

FINALLY, THAT WHATEVER ACTION WE MAY DECIDE UPON, THE

BASIC CRITERIA FOR OUR DECISION, MUST BE RESPECT FOR HUMAN RIGHTS AND THE

FREEDOM OF PEOPLE TO SHAPE THEIR OWN DESTINY BY EXERCISING THEIR OWN

CHOICES.

MR. PRESIDENT,

IT HAS LONG BEEN RECOGNIZED BY THE ILO THAT DEMOGRAPHIC FACTORS PLAY
A CRITICAL ROLE IN SOCIAL PROGRESS. ONE OF THE BASIC RATIONALES FOR
ILO''S INVOLVEMENT IN POPULATION AND RELATED ACTIVITIES IS THAT RAPID
POPULATION GROWTH, DIRECTLY AFFECTS THE DEMAND FOR EMPLOYMENT
OPPORTUNITIES. UNBALANCED POPULATION GROWTH, AND UNEVEN POPULATION
DISTRIBUTION, UNDERMINES THE ATTAINMENT OF THE CORE OF ILO OBJECTIVES OF
PROMOTING SOCIAL JUSTICE, FULL AND FREELY CHOSEN PRODUCTIVE
EMPLOYMENT, THE DIGNITY OF WORKERS AND IMPROVED WORKING CONDITIONS.

THE ILO IS WELL-PLACED TO ADDRESS SOME OF THE POPULATION ISSUES

OUTLINED IN THE PLAN OF ACTION. IN ITS SEARCH FOR SOCIAL JUSTICE, THE

ORGANIZATION HAS ADOPTED NUMEROUS INTERNATIONAL LABOUR STANDARDS THAT

HAVE DIRECT BEARING ON DEMOGRAPHIC MATTERS. THESE INCLUDE CONVENTIONS

AND RECOMMENDATIONS WHICH SERVE TO PROTECT THE RIGHTS OF MIGRANT

WORKERS; THOSE THAT ADDRESS EQUALITY OF OPPORTUNITY AND TREATMENT FOR

WOMEN AND OTHER VULNERABLE GROUPS; THOSE THAT PROTECT CHILDREN FROM

ECONOMIC EXPLOITATION; AND, FINALLY THOSE ON MATERNITY AND CONDITIONS OF

WORK OF WORKERS WITH FAMILY RESPONSIBILITIES.

THE PROGRAMME OF ACTION BEFORE US ALSO URGES COUNTRIES TO TAKE

MEASURES TO ELIMINATE ALL KINDS OF EXPLOITATION AND HARASSMENT OF WOMEN

AND CHILDREN (INCLUDING TRAFFICKING IN WOMEN AND CHILDREN AND FORCED

PROSTITUTION). ILO CONVENTIONS ON FORCED LABOR ARE IMPORTANT INSTRUMENTS

OF REDRESS IN THE CONTINUING BATTLE AGAINST SUCH ABUSES. MY ORGANIZATION
CAN ONLY APPLAUD AND SUPPORT ANY ACTION TO EMPOWER AND IMPROVE THE
STATUS OF WOMEN, AND GIVE THEM EQUAL OPPORTUNITIES WITH MEN. IN THIS
RESPECT, WE LOOK FORWARD TO THE BEIJING CONFERENCE AS YET ANOTHER
BUILDING BLOCK IN OUR ENDEAVOR TO CREATE A JUST NEW WORLD.

MR. PRESIDENT,

THE ISSUES UNDER CONSIDERATION IN THE PLAN OF ACTION ARE INTERLINKED IN VERY COMPLEX WAYS, SUCH THAT NEITHER ECONOMIC, SOCIAL NOR DEMOGRAPHIC GOALS CAN BE PURSUED IN ISOLATION. MOREOVER, ACHIEVEMENT OF EACH IS PROMOTED BY THE DEGREE TO WHICH SOCIAL JUSTICE AND EQUALITY REMAIN CENTRAL GOALS OF THE NATIONAL AUTHORITIES, CIVIL SOCIETY AND THE INTERNATIONAL COMMUNITY. IN SUM, ALL OUR ACTIONS SHOULD CONTRIBUTE TO ONE AND THE SAME OBJECTIVE: SUSTAINABLE DEVELOPMENT BASED ON HIGH QUALITY GROWTH WITH EQUITY.

THE ILO, I ASSURE YOU, CAN PLAY A VERY EFFECTIVE ROLE IN SUPPORT OF
THE IMPLEMENTATION OF THE POPULATION PROGRAMME OF ACTION. WE CAN DRAW
CONSIDERABLE STRENGTH FROM OUR UNIQUE TRIPARTITE STRUCTURE, WHICH
INCLUDES NOT ONLY GOVERNMENTS BUT ALSO WORKERS' AND EMPLOYERS'
ORGANIZATIONS. THE PRINCIPLE OF TRIPARTITE CONSULTATION AND ACTION IS
WHAT IS NEEDED IN THE WORLD OF TODAY - A WORLD THAT IS TRYING TO FIND A
NEW BALANCE BETWEEN THE STATE, THE MARKET AND SOCIETY. TRIPARTISM
PROVIDES OPPORTUNITIES FOR A BROADER REPRESENTATION OF CIVIL SOCIETY IN
THE DIALOGUE ON SOCIAL AND ECONOMIC DEVELOPMENT, INCLUDING POPULATION
POLICY THE ILO IS WELL PLACED TO PROMOTE THE PARTNERSHIP OF NOT ONLY
INTERNATIONAL ORGANIZATIONS, BUT ALSO THAT OF GOVERNMENTS, WORKERS AND
THE PRIVATE SECTOR IN IDENTIFYING NEW AREAS OF CO-OPERATION AS CALLED
FOR IN THE PROGRAMME. IN THIS RESPECT, THE ILO WILL CONTINUE TO PLAY THE
ROLE OF THE 'SOCIAL PILLAR' OF THE INTERNATIONAL COMMUNITY IN AS MUCH AS

ITS CENTRAL MANDATES - PROMOTION OF SOCIAL JUSTICE AND EQUALITY OF
OPPORTUNITY AND TREATMENT - ARE BASIC PLATFORMS FOR THE ACHIEVEMENT OF
THE GOALS OF THIS CONFERENCE'S PROGRAMME OF ACTION.

ACTIONS TO ADDRESS POPULATION ISSUES MUST ALSO BE PRACTICAL WE MUST STRIVE TO ADOPT STRATEGIES AND ACTIONS THAT HAVE A TIME SCOPE, ADDRESS CONCRETE AND WELL-DEFINED PROBLEMS ACCORDING TO SPECIFIC PRIORITIES AND TO DO SO WITHIN THE EXISTING RESOURCE CONSTRAINTS. I WOULD THEREFORE LIKE TO CALL UPON THIS CONFERENCE TO MOVE BEYOND OBJECTIVES THAT ARE TOO GENERAL TOWARDS SPECIFIC, WELL-DESIGNED AND FEASIBLE ACTIVITIES AND PROGRAMMES THAT ARE ALSO REALISTIC AND IMPLEMENTABLE. IN ILO'S EXPERIENCE, THIS IMPLIES INCREASING THE INSTITUTIONAL CAPACITIES OF MEMBER STATES TO DESIGN, IMPLEMENT AND MANAGE POPULATION AND DEVELOPMENT PROGRAMMES. IT ALSO IMPLIES INCREASING THE PARTICIPATION OF CIVIL SOCIETY AND THE GRASS ROOTS POPULATIONS IN THE DEVELOPMENT PROCESS, AND ENSURING CONTINUOUS EVALUATION OF THE PERFORMANCE OF THE PROGRAMMES AND PROJECTS ADOPTED.

MR. PRESIDENT,

THE SECRETARY GENERAL, DR BOUTROS-BOUTROS GHALI, HAS ASKED US TO FOCUS OUR ATTENTION ON "RIGOR TOLERANCE AND CONSCIENCE", AND I AM SURE THAT WE HAVE JUST DONE THAT.

WE ARE GATHERED HERE FOR A HISTORIC EVENT: TO TURN "THE PROGRAMME OF ACTION FROM WORDS TO ACTION. I AM SURE THAT NO ONE HERE WILL DISPUTE THE FACT THAT WE HAVE BEEN PARTY TO THE MAKING OF A SMALL MIRACLE IN THE LAND OF MIRACLES: EGYPT, WHOSE PRESIDENT, GOVERNMENT AND PEOPLE HAVE SPARED NO EFFORT TO MAKE THIS EVENT A SUCCESS. TO THEM I SAY "SHUKRAN". AND LIKE ALL MIRACLES, IT TAKES A WOMAN TO DELIVER IT. TO MY FRIEND AND

COLLEAGUE, NAFIS SADEK I SAY YOU HAVE MADE THE POINT FOR US ALL.

IN CONCLUSION, I WISH TO SAY THAT THE FINAL TEST FOR ALL OF US IS THE IMPLEMENTATION OF THE "PLAN OF ACTION". WE SHALL ALL BE JUDGED BY THIS.
