

As technology becomes increasingly embedded in everyday life, so too do the opportunities for its misuse to perpetrate gender-based violence. Sustained by discriminatory and harmful social and gender norms, technology-facilitated gender-based violence (TFGBV) manifests across a continuum of online and offline experiences of violence and can take many forms – from inequitable access to technology and nonconsensual surveillance to the creation and sharing of sexualized deepfakes and coordinated campaigns of gendered disinformation.

Addressing TFGBV is a key priority for UNFPA's work to ensure that all women and girls can live free from violence.

Although the forms of TFGBV may vary, they are all designed to control, demean and silence, leaving survivors with severe psychological, emotional, social or economic impacts. In some cases, the violence escalates to physical assault or femicide. Its silencing effect limits women and girls' access to technology, restricting their participation in public discourse and undermining their rights to safety, expression and autonomy. The online-offline continuum of TFGBV means that online violence frequently translates into offline or 'real-world' harm, and vice versa. For example, online harassment can lead to stalking and physical assault, while intimate partner violence may involve coercive control over a survivor's digital devices and online presence.

In its 2021 report, Making All Spaces Safe, UNFPA defined TFGBV as "an act of violence perpetrated by one or more individuals that is committed, assisted, aggravated and amplified in part or fully by the use of information and communication technologies or digital media, against a person on the basis of their gender". Since the release of this report, UNFPA has accelerated its programmes and research to deepen understanding of TFGBV and identify the most effective strategies for prevention and response to be implemented by national, regional and global stakeholders. This compendium, as a live document, intends to capture that progress, showcasing the technical guidance, research and advocacy tools developed across UNFPA offices.

Making All Spaces Safe

UNFPA tackles all forms of TFGBV through comprehensive programming aligned with the key pillars of Response, Prevention, Enabling Environments, and Data and Research, as iterated in the UNFPA Gender-based Violence Operational Plan, Flourish. This approach is further reflected in the dedicated global programme, Making All Spaces Safe, implemented in partnership with Global Affairs Canada. 



BODYRIGHT CAMPAIGN

UNFPA's 'bodyright' campaign is a global initiative demanding that TFGBV – specifically the non-consensual use of personal images – be treated as a human rights violation. Its central message is a powerful call to action: that human bodies and images of them should be given the same value and legal protection online as copyrighted materials such as corporate logos or music.
